ARE YOUR YOUTH BOWLERS & PARENTS AWARE OF THE RULES???

- 1. This tournament is certified by the United States Bowling Congress and shall be governed by USBC rules.
- 2. Competition is open to all 2023-2024 AZ State USBC Youth members. To compete, a bowler must be a regular member of a certified USBC Youth League bowling in an AZ bowling center between September 1, 2023, and October 27, 2023, and not be under suspension at the time of qualifying.
- 3. League substitutes can participate if it is their only USBC Youth league. USBC Collegiate members are eligible if they are 2023-2024 Youth members, bowling in an AZ USBC Youth league and have not violated USBC Rule 400.
- 4. Participants must be aware of each competition level in the state/zone and all associated rules, fees, and deadlines. These items are contained in the specific state/zone rules from the State/Zone Pepsi Tournament Director (director information can be found on bowl.com).
- 5. Competition will be conducted in 10 divisions based on the participant's age. Participation in the wrong age division will lead to automatic disqualification. Bowlers must stay in the given division for their particular league throughout the entire window: All Divisions will be Scratch.

 - a. Their highest current certified league average, as of October 27, 2023, of 15 games or more.
 - b. If no average with the 15-game minimum as of October 27, 2023, then a bowler's history of a 15-game average bowled closest to the date of competition may be used. If a bowler has ONLY a sport league average, then USBC Rule 201C will be used. The average adjustment chart in the USBC Rulebook will determine the "correct" average to be used.
 - c. The highest book average from 2022-2023 bowling season
 - d. If a, b, or c does not apply, Bowler will be given a 220 average. Each league must provide an alphabetical list of their bowler's averages as of October 27,2023, to include ONLY bowlers name, totalpins, games bowled, and average.
- 10. No substitutes will be permitted **once athletes have started tournament play.** However, replacements may be used for bowlers who are not present 15 minutes prior to the squad time. Competitors shall be allowed 10 minutes of practice time on their starting pair.
- 11. If no replacement has been made, bowlers arriving late shall begin play and the score shall count beginning with the frame then being bowled. Missed frames shall be credited with a zero. **Frames may not be made-up**. Bowlers who are not present when it is their turn to bowl will be credited with a zero for that frame.
- 12. Only Tournament Bowlers, tournament officials, and center staff shall be permitted in the settee area.
- 13. Claims for errors in scoring or general playing rules must be made to the tournament director no later than the start of the next block or 30 minutes after the completion of competition. Questionable errors shall be decided upon by the tournament director. All other protests must be confirmed in writing to the tournament director within 72 hours of the infraction. Under this rule, each protest must be specific in itself.
- 14. Symbolic awards will be given on a ratio of 1 in 10.
- 15. Scholarships will be awarded to the first place in each of the U-8, U-10, U-12, U-15, & U-18 divisions from each of the sectional sites. Additional places will be given awards if entries warrant.
- 16. Advancement from each of the sectional sites to the state level of competition will be the first 5 places in each of the U-12, U-15, and U-18 Boys & Girls Divisions. In all cases at leas t one individual per division shall advance
- 17. Appropriate attire shall be worn and will be neat, clean, and proper fitting. Non-tattered blouses, shirts, or jerseys must have a **Butterfly Collar or a MOCK COLLAR**, it must have sleeves and be hip length if not tucked in. Nice Pants or Jeans with **NO FRAYED HEMLINES**; SHORTS **may be worn if they go past the fingertips 2 inches while standing with arms relaxed by their side. NO SPORT SHORTS, sweatpants, gym pants, or Leggings WILL BE ALLOWED).** Bowlers will not wear hats/caps (unless medically approved). Youth are to be in bowling attire when checking in and must stay in the approved attire until finish bowling. Youth participants will not wear apparel or use bowling equipment depicting alcohol, tobacco, gambling, an illegal substance, or inappropriate Language/gestures during competition (USBC Rule 301b). Athletes may not smoke or consume alcoholic beverages. The settee and concourse areas will be smoke and alcohol free. This includes E-Cigs. Smoking and alcohol consumption by non-participants will be in designated areas only. *No electronic devices will be used by bowlers while bowling in the tournament.*

This tournament is certified by the United States Bowling Congress and shall be governed by USBC rules.

- 1. Advancement from league is a one-time entry. If an individual who qualified cannot participate in the state/zone competition, replacements will be eligible based on order of finish in previous competition. Replacements must be from the same sectional site as the individual unable to compete.
- 2. Advancement from the sectional sites will be the first 5 places from the Northern site and the first 5 places from the Southern site for each of the U-12, U-15, and U18 Boys and Girls Divisions. In all cases at least one person per division shall advance.
- 3. Advancers out of the league level must remain in the division they qualified in during all subsequent levels. If a bowler advances out of league level in more than one state/zone, the bowler must declare one state/zone to continue competing before the next competition level. Participation in any level of competition past the league level in more than one state/zone will result in automatic disqualification.

 - b. If no average with the 15-game minimum as of March 1, 2024, then a bowler's history of a 15-game average bowled closest to the date of competition may be used. If a bowler has ONLY a sport league average, then USBC Rule 201C will be used. The average adjustment chart in the USBC Rulebook will determine the "correct" average to be used.
 - c. The highest book average from 2022-2023 bowling season
 - d. If a, b, or c does not apply, Bowler will be given a 220 average. Each league must provide an alphabetical list of their bowler's averages as of March 1, 2024, to include ONLY bowlers name, total pins, games bowled, and average.
- 11. Appropriate attire shall be worn and will be neat, clean, and proper fitting. - 14. Only bowlers, tournament officials and center staff shall be permitted in the settee area. If needed the Tournament Director may authorize additional people in the settee area on a case by case basis but if only determined necessary by the Tournament Director.
- 15. Ties will be broken by a one game roll-off. Should a tie still exist, it will be broken by an additional 9th and 10th frame roll-off. (Refer to rule 326a).
- 16. Claims for errors in scoring or general playing rules must be made to the tourn ament director no later than 30 minutes after the completion of competition. Questionable errors shall be decided upon by the tournament director. All other protests must be confirmed in writing to the tournament director within 72 hours of the infraction. - 20. All advancers to The Junior Gold Championships must have a USBC Junior Gold membership or purchase a USBC Junior Gold membership prior to the championships. These athletes will compete for additional scholarships available to all athletes at the championships, as well as other prizes and awards. The Arizona State USBC will provide a \$200.00 stipend to the first-place winners of the U-12, U-15, and IJ-18 Boy & Girl divisions to offset some of their expenses to the Junior Gold Championships. The Stipend will be issued after participating in the Tournament and upon the presentation of supporting receipts of adual expenses to the Tournament Director. All U. S. citizens are vying for a spot on USBC Junior Team 2024 to represent the United States in national and international competition. If the U-12, U-15, and U-18 division champions are unable or unwilling to become a USBC Junior Gold member, he/she will not advance to the Championships. The athlete will still retain the state/zone scholarships, but the berth and any available stipends to the 2024 Junior Gold Championships will be awarded to the next eligible athlete. Winners are not confirmed as national finalists until they receive a confirmation letter from the National USBC IBC Youth Tournaments Team.
- 21. Eligible advancers must agree to bowl in the Junior Gold Championships; failing to do so, you agree to waive all your rights and replacements will be selected based on the order of finish in their division at the state level. Replacements will incur all costs associated with changing the airline ticket, if applicable.

- 8. If no replacement has been made, bowlers arriving late shall begin play and the score shall count beginning with the frame then being bowled. Missed frames shall be credited with a zero. **Frames may not be made-up.** Bowlers who are not present to bowl when it's their turn will be credited with a zero for that frame.
- 9. AVERAGES: Bowlers shall use one of the following methods:
 - a. their highest current certified league average, as of October 27, 2023, of 15 games or more.
 - b. If no average with the 15-game minimum as of October 27, 2023, then a bowler's history of a 15-game average bowled closest to the date of competition may be used. If a bowler has ONLY a sport league average, then USBC Rule 202D will be used. The average adjustment chart in the USBC Rulebook will determine the "correct" average to be used.
 - c. The highest book average from 2022-2023 bowling season
 - d. If a, b, or c does not apply, Bowler will be given a 220 average for handicap average.

Handicap shall be 90% of the difference between the bowler's average and 220. Each league must provide an alphabetical list of their bowler's averages as of October 27, 2023, to include ONLY bowlers name, total pins, games bowled, and average.

- 10. Only bowlers, tournament officials and center staff shall be permitted in the settee area. If needed the Tournament Director may authorize additional people in the settee area on a case-by-case basis but if only determined necessary by the Tournament Director.
- 11. Appropriate attire shall be worn and will be neat, clean, and proper fitting. Non-tattered blouses, shirts, or jerseys must have a **Butterfly Collar or a MOCK COLLAR**, it must have sleeves and be hip length if not tucked in. Nice Pants or Jeans with **NO FRAYED HEMLINES** or **SHORTS may be worn if they go past the fingertips 2 inches while standing with arms relaxed by their side. - 12. All Ties for 5th place will all advance to state finals.
- 13. Claims for errors in scoring or general playing rules must be made to the tournament director no later than the start of the next block or 30 minutes after the completion of competition. Questionable errors shall be decided upon by the tournament director. All other protests must be confirmed in writing to the tournament director within 72 hours of the infraction. Under this rule, each protest must be specific in itself.
- 14. Symbolic awards will be given on a ratio of 1 in 10.
- 15. Scholarships will be awarded to the first place in each of the 11 & Under Divisions from each sectional site. Additional places will be given awards if entries warrant.
- 16. Advancement from each of the sectional sites to the state level of competition will be the first 5 places in each Boys & Girls 12 & Above Divisions. In all cases at least one individual per division shall advance.
- 17. All matters not covered by these rules and regulations shall be determined by the State/Zone Handicap AZ USBC Youth Championships Tournament Committee. Tournament Committee reserves the right to accept or reject any participant.

- 1. This tournament is certified by the United States Bowling Congress and shall be governed by USBC rules.
- 2. Advancement from league is a one-time entry. If an individual who qualified cannot participate in the state/zone competition, replacements will be eligible based on order of finish in previous competition. Replacements must be from the sectional site of the individual unable to compete.
- 3. Advancement from the sectional sites will be the first 5 places from the Northern site and the first 5 places from the Southern site from each of the 12 & Above Division Boys and 12 & Above Division Girls; this includes all ties for 5th,—Place. In all cases at least one person per division shall advance.

 4. Advancers out of the league level must remain in the division they qualified in during all subsequent levels. If a bowler advances out of league level in more than one state/zone, the bowler must declare one state/zone to continue competing before the next competition level Participation in any level of competition past the league level in more than one state/zone will result in automatic disqualification.
- 5. **Entry closing date** is **March 1, 2024.** Tournament entry form containing qualifiers name, address, telephone number and Bowler Certification number must be submitted to the tournament director per Sectional Rule 6.
- 6. Divisions are based on the participant's age as of August 1, 2023. Competition shall be conducted in the following divisions: 12 & Above Boys Handicap, 12 & Above Girls Handicap.
- 7. **Tournament Format:** The top 20 bowler's advancement is based on the Sectional sites as stated in rule 3. All previous scores will be dropped. Bowlers will bowl 6 games across 6 lanes, moving 1 pair to the right after every 2 games their handicap will be applied to these scores. The bowler's 6 game scores with handicap will determine their final standing in this tournament.
- 8. **Entry fee .is \$35.00.** Payable at tournament site by league check, money order, cashier's check, personal checks, or cash will be accepted. If using a check or money order it must be made payable to:

A fee of \$30.00 will be assessed for all returned checks

- 9. No substitutes will be permitted **once athletes have started tournament play,** however, replacements may be used for bowlers who are not present 15 minutes prior to the squad time. **Replacements in the State**Finals must be from the order of finish from the Sectional level of competition.
- 10. If no replacement has been made, a bowler arriving late shall begin play and the score shall count beginning with the frame then being bowled. Missed frames shall be credited with a zero. **Frames missed may not be made-up.** A bowler not present when it is their turn to bowl will be credited zero for that frame.
- 11. AVERAGES: Bowlers shall use one of the following methods:
 - a. Highest current certified league average, as of October 27, 2023, of 15 games or more.
 - b. If no average with the 15-game minimum as of October 27, 2023, then a bowler's history of a 15-game average bowled closest to the date of competition may be used. If a bowler has ONLY a sport league average, then USBC Rule 202D will be used. The average adjustment chart in the USBC Rulebook will determine the "correct" average to be used.
 - c. The highest book average from 2022-2023 bowling season
 - d. If a, b, or c does not apply, Bowler will be given a 220 average for handicap average.

Each league must provide an alphabetical list of their bowler's averages as of October 27, 2023, to include **ONLY** total pins, games and average. Handicap shall be 90% of the difference between the bowler's average and 220.

- 12. Only bowlers, tournament officials and center staff shall be permitted *in* the settee area. If needed the Tournament Director may authorize additional people in the settee area on a case-by-case basis but if only determined necessary by the Tournament Director.
- 13. Appropriate attire shall be worn and will be neat, clean, and proper fitting. Non-tattered blouses, shirts, or jerseys must have a **Butterfly Collar or a MOCK COLLAR**, it must have sleeves and be hip length if not tucked in. Nice Pants or Jeans with **NO FRAYED HEMLINES** or **SHORTS may be worn** if **they go past the fingertips 2 inches while standing with arms relaxed by their side. NO SPORT SHORTS, sweatpants, gym pants, or Leggings WILL BE ALLOWED).** Bowlers will not wear hats/caps (unless medically approved).  15. Claims for errors in scoring or general playing rules must be made to the tournament director no later than 30 minutes after the completion of competition. Questionable errors shall be decided upon by the tournament director. All other protests must be confirmed in writing to the tournament director within 72 hours of the infraction. Under this rule, each protest must be specific in itself.
- 16. Symbolic Awards will be given out to the top bowlers on a ratio of 1 in 10.
- 17. Scholarships will be presented to finalists on a ratio of 1 in 5 of the Sectional Entries in each of the 12 & above divisions. The tournament director is responsible for submitting the scholarships and recipients to the SMART Program, who will administer the scholarships. Scholarships will be held in SMART Account #08583. - 18. The First Place Winners and Runner up of the 12 & Above Boys and Girls HDCP will receive paid entries into the 2024 Bowling.com Youth Open Championship in Detriot, MI on July 12-20, 2024, with entry fees paid by AZ State USBC Youth for Scratch and Handicap Team, Doubles, Singles, & All Events. The Arizona State USBC will provide a \$200.00 stipend to the first-place winners and runner ups to offset travel cost for the National Youth Open Tournament. Advancers will be required to be accompanied by a parent, guardian, or coach. The national finals do not provide chaperones. The stipend will be issued after participating in Tournament and upon the <u>presentation of supporting receipts of actual expenses to the Tournament Director.</u>
- 19. All matters not covered by these rules and regulations shall be determined by the State/Zone Handicap AZ USBC Youth Committee. Tournament Committee reserves the right to accept or reject any participant.
