## 2023-2024 Kentucky Pepsi USBC Youth Championships Sectional Level Rules and Format Walk Ins Welcome

1. This tournament certified by the United States Bowling Congress (certification \#05403) and governed by USBC rules.
2. One time entry. If an individual qualified cannot participate in this competition, replacements will be eligible based on order of finish in previous level of competition. Bowlers can bowl any squad they would like Saturday or Sunday.
3. Advancement ratio from league competition to sectional competition is a one (1) to one (1) ratio.
4. Advancers out of the league level must remain in the division they qualified in during all subsequent levels. If a bowler advances out of league level in more than one state/zone, the bowler must declare one state/zone to continue competing before the next competition level. Participation in any level of competition past the league level in more than one state/zone will result in automatic disqualification.
5. All sectional competition will take place March 2-3 \& 9-10, 2024. Bowlers will bowl at Executive Strikes \& Spares 911 Phillips Lane Louisville, Ky. 40209 (502) 368-1651. Qualifiers will assign a shift time for Saturday \& Sunday 12:00pm. State finals will be held in Louisville, Kentucky on March 23-24, 2024 at Kingpin Lanes 9525 Taylorsville Road (502) 7195474 Jeffersontown, Ky. 40299. March 23, 2024 U8, U10, U12 will bowl at 10:00am Eastern Time March 24, 202418 \& Under \& 15 \& Under will bowl at 9:00am Eastern Time.
6. Entry closing date is March 10, 2024. Qualifier's name, address, telephone number, date of birth, average, last 4 digits of the social security number and tournament entry fees must be submitted by this date to the tournament director.
7. These are the divisions for Pepsi competition:

Divisions U8 and U10 will bowl three games on one pair of lanes. Total scratch pin fall will determine the advancers. The top 30 bowlers per division per division will advance to the state finals.

Divisions U12, U15 and U18 will bowl four games on one pair of lanes. Total pin fall will determine the top 30 advancers in each division, at each sectional including all ties.
8. The state level will have 30 athletes in each division. The number of bowlers advancing to the state finals will be determined by the size of each sectional. The seeds into the state will be given to the top bowlers from each sectional competition in each division.

EXAMPLE: Sectional 1 has 79 boy's bowlers; Sectional 2 has 240 boy's bowlers.

10. All bowlers must wear suitable attire. Fringes, fishnets, midriffs halters, tank tops or head attire may not be worn. Obscene figures or derogatory writing on clothing or patches are not acceptable. Anything not mentioned above will be left to the discretion of the tournament director. This code will be enforced and any break of these standards will result in removal of bowling privileges. The USBC Jersey shirt is okay to wear in the Pepsi Tournament.
11. Youth participants will not wear apparel or use bowling equipment depicting alcohol, tobacco, gambling, an illegal substance or inappropriate language/gestures during competition.
12. No substitutes will be permitted.
13. Competitors will be allowed (10) minutes of practice on their starting lanes only.
14. Bowlers arriving late shall begin play and the score shall count beginning with the frame then being bowled. Missed frames shall be credited with a zero. Bowlers not present to bowl when it's their turn will be credited with a zero for that frame.
15. Only bowlers and tournament officials shall be permitted in the settee area.
16. If a tie exists for the last advancing place, all ties for that positions will advance to the state finals.
17. Claims for errors in scoring or general playing rules must be made to the tournament director no later than the start of the next block or 30 minutes after the completion. The tournament director shall decide upon questionable errors. All others protests must be confirmed in writing to the tournament director within 72 hours or before the awards are presented. Under this rule, each protest must be specific in itself.
18. Scholarships will be awarded on a least 1 to 10 ratio.
19. Scholarships (deposited in Smart) will be given at state level for the top five winners in each divisions, based on 290 entries U8 and U10, 350 entries for U12, U15 and U18.
20. The Kentucky State Pepsi USBC Youth Championships Tournament Committee shall determine all matters not covered by these rules and regulations. The National Pepsi USBC Youth Championships Tournament Committee reserves the right to accept or reject any participation.
21. Rule 301B Youth will be enforced.
22. Tournament Directors will be Bill Carter.

## 2023-2024 Kentucky Pepsi Youth Championships State Level Rules And Format

1. This tournament is certified by USBC (Certification \#05403) and shall be governed by USBC rules.
2. One time entry. If an individual has qualified but cannot participate in this level of competition, replacement will be eligible based on the order of finish in previous competitions.
3. Advancement from sectional level to the state level. The seeds into the state will be given from each sectional competition in each division on a percentage of the overall actual participants in each division at the sectional level.
4. Advancers out of the league level must remain in the division they qualified in during all subsequent levels. If a bowler advances out of league level in more than one state/zone, the bowler must declare one state/zone to continue compering before the next competition level. Participation in any level of competition past league level in more than one state/zone will result in automatic disqualification.
5. State finals competition will take place at Kingpin Lanes, 9525 Taylorsville Road Jeffersontown, Ky. 40299. (502)7195474 March 23-24, 2024.
6. Entry closing date is "March 10, 2024".
7. Competition will be conducted in ten (10) divisions, U8, U10, U12, U15 \& U18. All divisions will be scratch. Participation in the wrong age division will lead to automatic disqualification.
8. Divisions U8 and U10 will bowl three (3) games. Total pin fall will determine the top five (5) winners in each division. Divisions U12, U15 and U18 will bowl six (6) games. Lane rotation will be: left lane will move left right lane will move right after each game. Total pin fall will determine the top five (5) in each division for the step ladder finals.
9. There is no entry fee at state level.
10. All bowlers must wear suitable attire. Fringes, fishnets, midriffs, halters, tank tops or head attire may not be worn. Obscene figures or derogatory writing on clothing or patches are not acceptable. Anything not mentioned above will be left to the discretion of the tournament director. This code will be enforced and any breaking of these standards will result in removal of bowling privileges. The USBC Jersey shirt is okay to wear in the Pepsi Tournament.
11. Youth participants will not wear apparel or use bowling equipment depicting alcohol, tobacco, gambling, an illegal substance or inappropriate language/gestures during competition.
12. No substitutions will be permitted; however, eligible replacement may be used for bowlers who are not present 15 minutes prior to the start of bowling as stated in Rule 2.
13. Competitors will be allowed ten (10) minutes of practice on their starting lanes only.
14. Bowlers arriving late shall begin play and the score shall count beginning with the frame where they are bowling in. Missed frames shall be credited with a zero. Bowlers not present to bowl when it's their turn will be credited with a zero for that frame.
15. Only bowlers and tournament officials shall be permitted in the settee area.
16. A one game roll off break ties for the top five (5) spots. Should a tie exist, it will be broken by an additional ninth and tenth frame roll off.
17. Claims for errors in scoring or general playing rules must be made to the tournament director no later than the start of the next block or 30 minutes after the completion of competition. The tournament director shall decide upon questionable errors. All others protests must be confirmed in writing to the tournament directors within 72 hours or before the awards are presented. Under this rule, each protests must be specific in itself.
18. Scholarships will be awarded to the top five (5) in each division in the conclusion of the state finals.
19. Scholarships will be given at state level for the top five (5) winners in each division, based on 290 entries for U8, U10, 350 entries for U12, U15 and U18.
20. The first place winners in the U12, U15 and U18 boys and girls divisions will advance to the Junior Gold Championships to be held July 2024 in Indianapolis, In. Advancers must be USBC Junior Gold members to advance or purchase a USBC Junior Gold Membership prior to the Junior Gold Championships. USBC will waive the $\$ 200$ (U18) $\$ 150$ (U15) and $\$ 100$ (U12) entry fee for these division champions. These athletes will compete for additional scholarships available to all athletes at the Junior Gold Championships, as well as other prizes and awards. All U.S. citizens are vying for a spot on USBC Junior Team USA 2024 to represent the United States in national and international competition. If the division champion is unwilling or unable to become a USBC Junior Gold member they will not advance to the Junior Gold Championships. The athlete will still retain the state/zone scholarships, but the berth to the championships will be awarded to the next eligible athlete. No travel expenses are provided by USBC.
21. Advancers must agree to bowl in the Junior Gold Championships, or failing to do so agree to waive all rights. Replacement will be selected based on the order of finish in their division at the state level. Replacement will incur all expenses associated with changing the airlines ticket, if applicable.
22. All matters not covered by these rules and regulations shall be determine by the Kentucky State Pepsi USBC Youth Championships tournament committee. The National Pepsi USBC Youth Championships Tournament Committee reserves the right to accept or reject any participant.
23. Rule 301B Youth will be enforced 2023-2024 season.
24. Bill Carter will be running State Finals in Louisville Kentucky.
