TOURNAMENT RULES- TO BE RETAINED BY ENTRANT

1. All entrants must be current USBC Certified youth members from a State of Massachusetts league who have not reached their 18th birthday by August 1, 2024.
2. All rules and regulations of the USBC Youth will govern this tournament.
3. All Youth Bowlers must abide by USBC Youth Code. This means NO foul language or gestures. NO chewing tobacco, NO playing video games and NO electronic devices may be used during squad time and competition. The Tournament Director has the right to disqualify any bowler for failure to comply. Only USBC certified products that meet the youth guidelines can be used.
4. Dress Code: Bowlers must wear a center or league issued shirt, collared shirt, USBC youth jersey, mock collared shirt or USBC apparel, slacks, jeans with no holes worn at the waist. Shorts or skirts/skorts must be below the competitor's fingertips when they are standing and their arms are hanging loosely at their sides. There will be no headgear allowed (unless medically necessary with a doctor's note). All bowlers meet the requirements of USBC rule 301b youth. Any bowler found not abiding by the dress code, will be removed from the tournament.
5. Deliberate falsification of average will result in disqualification, forfeiture of all fees and possible suspension from USBC.
6. The Tournament Director will settle all disputes and complaints. All protests must be submitted in writing to the Tournament Director or USBC Headquarters within 72 hours of such protested event. The tournament director will consult with the MASS STATE USBC YOUTH COMMITTEE.
7. The entrants whose names appear hereon or their authorized replacement hereby agree that the MASS STATE USBC YOUTH COMMITTEE, its officers and agents, shall be liable only to the extent of returning entry fees if and when these entrants shall be prevented from bowling any event in the tournament through, delay, unexpected yet necessary schedule change or premature termination of the tournament which may be brought about by war, strikes, lockouts, labor difficulties or other causes beyond the control of the MASS STATE USBC YOUTH COMMITTEE.
8. The Tournament Director reserves the right to add or delete squads if necessary. Squad dates and times are assigned on a first come first serve basis. The Tournament Director will assign lanes.
9. No one other than the bowlers, scorekeepers or Tournament Officials will be permitted in the bowling area. Bowlers must stay in the bowling area during the match unless permission to leave is given by the scorekeeper or Lane Marshall. NO food or beverage will be allowed in the bowling area. NO FLASH PHOTOGRAPHY OR ELECTRONICS ALLOWED.
10. Automatic foul detectors will be used and observed in every event. If there are any questions as to a foul, the Official Scorekeeper and/or Lane Marshall may make a decision otherwise shall contact the Tournament Director who shall be sole judge in a case of a dispute.
11. If within 30 days after the completion of the tournament the winner is disqualified because of an error or any reason, the bowler with the next highest pin fall will be awarded the award.
12. Scholarships will be given based on a ratio of at least 1:10. All scholarships shall be returned 100%.
13. All bowlers will receive a confirmation at least 5 days prior to the tournament. If you do not receive a confirmation 5 days prior, please call the tournament director.
14. Applications will only be accepted if completed in full and accompanied with the proper entry fee. **NO entry fees will be returned after the tournament closing date. All checks are payable to MASS STATE USBC. THERE WILL BE A THIRTY-FIVE DOLLAR (\$35.00) FEE CHARGED ON ALL RETURNED CHECKS.**
15. All matters not covered by these rules will be determined by the Tournament Committee.
16. There will be five minutes of practice on each of the starting pair of lanes. Competition begins when the 1st ball is thrown and therefore no surface alterations from that point on will be allowed.
17. A late bowler, or one who leaves during a game, will be given ZERO for each frame missed; tardy bowlers shall begin in the frame then being bowled (no make-up allowed). Entrants must bowl in the order shown on their form. A substitute must bowl in the position of the bowler being replaced. Substitutes must follow the same eligibility rules as the original entrant. No blind scores will be permitted. **NO PACERS WILL BE ALLOWED. THERE WILL BE NO ABSENTEE SCORES ALLOWED. If bringing a replacement, the replacement must fill the vacancy in the same division and center, they must register at least 30 minutes prior to squad time** and must be signed by the Program Director, Coach or team representative. If there is no authorized person to make the change, it will be up to the Tournament Director/or his/ her designee to make the change in order to make sure each registered youth bowler that has showed up has the opportunity to bowl. Any award won by the replacement is the property of the replacement. **A replacement is official at squad time. The Mass State Youth Committee is not responsible for finding subs.**

18. **MAIL IN ENTRIES CLOSE – MARCH 10, 2025.** WALK INS ACCEPTED DAY OF EVENT (\$55.00 ENTRY FEE per bowler U12, U15 & U18 divisions; \$35.00 ENTRY FEE per bowler U8 & U10 divisions) - CASH ONLY, subject to lane availability and MUST REGISTER between 8:30-9:00AM. NO CHECKS accepted after mail in entry close date.
19. **FORMAT:** Tournament will consist of one three game block across three pairs of lanes with the top eight bowlers in U12, U15 and U18 divisions moving on to the finals. U8 and U10 divisions will bowl 3 games on the same pair of lanes. ****Tournament will be bowled on a challenge oil pattern****
20. **DIVISIONS:** Divisions are based on the participant's age as of August 1, 2024. Athletes must choose the division in which they will compete. Competition will be conducted on a **SCRATCH** basis only:
There are a total of 10 divisions.

- U8 Boys or Girls are those bowlers whose birth date is 8/1/2016 or later
U10 Boys or Girls are those bowlers whose birth date is 8/1/2014 through 7/31/2016
U12 Boys or Girls are those bowlers whose birth date is 8/1/2012 through 7/31/2014
U15 Boys or Girls are those bowlers whose birth date is 8/1/2009 through 7/31/2012
U18 Boys or Girls are those bowlers whose birth date is 8/1/2006 through 7/31/2009
21. **You must bowl in your age division, UNLESS you want to move UP to a higher division with form approval.**
22. **FINALS: Divisions U12, U15 and U18.** The top 8 from each of these divisions will bowl one three game block. The top three (total scratch pin fall) will bowl a stepladder final (three bowls two; winner bowls one) in their division. In the event of a 1st and or 2nd place tie in any division a 9th & 10th frame will be bowled. If tie still exists, it will be repeated until tie breaks. All Bowlers will have 2 practice balls per lane in the finals. #1 Seed will be allowed a lane for warm up after the 5th frame of match 2 vs. 3 if requested.
23. **1ST PLACE WINNERS:** Divisions U12, U15 and U18 divisions for both girls and boys will advance to the 2025 Junior Gold Championships on JULY 11-19, 2025 in Greenbay, WI. You must be USBC Junior Gold members to advance to the Junior Gold Championships. Bowlers without a current Junior Gold membership must purchase one prior to 6/1/25. USBC will waive the \$200 (U18) and \$150 (U15) and \$100 (U12) entry fee for these athletes. These athletes will compete for additional scholarships at the championships, as well as other prizes and awards. All US citizens are vying for a spot on the USBC Junior Team USA 2026 to represent the United States in national and international competitions. If the U12, U15 and U18 division champion is unwilling or unable to become a Junior Gold member, they will not advance to the Junior Gold Championships. They will however, still retain the state scholarship, but the berth to the Junior Gold Championships will be awarded to the next eligible athlete. Travel and accommodation expenses will be the responsibility of the bowler. In the event that a qualifier needs to be replaced and there is a tie to determine who will advance to the Junior Gold Championships, the high game from the qualifying scores will determine who will advance. If the high score for each is the same, next subsequent high score will be used until the tie is broken.
24. **AVERAGE:** Averages used at the state level will be the **Higher** of the following:
a) Highest league average as of January 1, 2025, minimum of 12 games
b) If no such average exists, use higher of the current league average as of entry close date of at least 12 games
c) Challenge and Sport averages will be converted using the USBC conversion table.
d) All others must bowl scratch
25. In the event of a tie the scholarship for that position and the following position will be combined and split equally.
26. **Scholarships will be held in the SMART FUND account number 8526 program at the USBC Headquarters.**
