**2024 OHIO STATE USBC YOUTH – PEPSI CHAMPIONSHIPS
DISTRICT RULES AND FORMAT**

1. This tournament is certified by the United States Bowling Congress (Certification Numbers 5000, 5001, 5002, 5003, 5004) and shall be governed by USBC rules. All competition levels - District and State - are based on scratch competition.
2. Advancement from District level to State level is a one-time entry.
3. Advancement ratio from the District level to the State level competition will be one (1) out of every two (2) entries, or major fraction thereof, including last-place ties, in each division as of date of birth, as of July 31, 2024:

A youth who elected to move up from a lower age division to a higher age division (a waiver must have been completed) must also remain in the higher age division throughout the State competition. In all cases, at least one (1) individual shall advance. The advancement ratio shall be applied uniformly to all eligible divisions.

4. Participants must be made aware of all competition levels in the District/State and all associated rules, fees and deadlines.
5. District competition will take place on dates indicated on the enclosed form (Form C) which contains Center Name, Address, City, dates, times, and District Directors information for your District level.
6. ON-LINE REGISTRATION is the preferred method of entry and payment. If mailing, you must mail to the district director the following information: Bowler’s entry form and required entry fee. Deadline date is February 14, 2024 for submitting entries. This deadline will be enforced.
7. Competition shall be conducted in ten (10) divisions, see rule #3. **These divisions are based on the participant’s date of birth as of July 31, 2024.**
8. All bowlers will bowl three (3) games at the District level.
9. District level entry fee for all divisions is:

(Award and scholarship fees will be returned 100% to bowlers.)

No refunds will be given once confirmation is sent.

Confirmation letters WILL be sent by the on-line registration platform to the email on file.

Dates/times will be posted on our website, www.ohiostateusbc.com, under the Pepsi Tournament section.

10. **Scholarships will be administered by the National USBC SMART Program (account #8540). Please contact SMART (1-800-514-2695, ext. 8292) or write to: USBC SMART Program, 621 Six Flags Drive, Arlington, TX 76011.**
11. Dress code: Entrants are expected to wear suitable attire. Use good judgment when selecting the appropriate attire. Examples of prohibited attire include but are not limited to: **short shorts or any shorts, pants hanging showing underwear and/or body parts, headgear/headwear(unless medically necessary), T-shirts with alcohol or cigarette advertisements, sleeveless shirts/blouses, or tank tops.** Bowlers will be required to change if attire is deemed inappropriate by the Tournament Director. The Tournament Director's decision will be final. Failure to comply with any dress code rule will result in a verbal warning and apparel change (if applicable). Second offense will result in disqualification from the tournament. Please be presentable. **Inappropriate language or gestures or gambling will not be permitted. Electronic devices (including cell phones) will not be permitted on the approach during delivery.**
12. **Tobacco products, e-cigarettes, or alcohol will not be allowed by the athletes or guests on the concourse nor in the settee area during competition.**
13. Bowlers must show a current USBC membership card at check-in. If they do not have a current membership card, they can go to www.bowl.com under "Find a Member" and follow the prompts to print a card.
14. Competitors shall be allowed ten (10) minutes of practice prior to their starting time on their assigned lanes only. There will be no bowling by tournament bowlers on the tournament lanes prior to the start of the tournament on their scheduled tournament day.
15. Bowlers arriving late shall begin play with the frame being bowled. Frames missed shall be credited with a zero. Frames missed cannot be made up. Bowlers not present to bowl when it's their turn will be credited with a zero for that frame.
16. **High School League bowlers must qualify in a USBC certified league.**
17. Only bowlers and tournament officials shall be permitted in the bowling area during competition.
18. Claims for errors in scoring or general playing rules must be made to the District Director no later than the start of the next block or thirty (30) minutes after the completion of competition. Questionable errors shall be decided upon by the District Director. All other protests must be confirmed in writing to the District Director within seventy-two (72) hours of the infraction. Under this rule, each protest must be specific.
19. Symbolic awards will be given to all bowlers in each of the divisions who participate at the district level.
20. Scholarships will be awarded at a ratio of one (1) out of every seven (7) entries per division or major fraction thereof, based on entries received at the District level for all divisions. In case of a tie for any place, duplicate scholarships will be awarded.
21. The State level competition will take place in Columbus, Ohio on May 3rd, 4th, 5th, and May 10th, 11th, & 12th 2024 at **Columbus Square Bowling Palace, 5707 Forest Hills Blvd, Columbus, OH 43231** Telephone (614) 895-1122, for all divisions. All State finalists will be notified by mail of their advancement and provided with an entry code to complete on-line registration for their date and time at the state level.
22. The Tournament Director will be responsible for enforcing the rules and resolving disputes during the tournament. Only tournament officials and bowlers are permitted in the bowler's area. The bowler, by voluntary participation in the Championships, agrees to comply with the final decision of the Tournament Director.
23. All participants & parents/guardians agree to allow the Ohio State USBC to use their photograph for publicity purposes. In the event the Ohio State USBC arranges for telecasts or broadcasts of the tournament, it would be without cost to participants/parents/guardians and participants/parents/guardians would not share any revenue derived therefrom.

24. The entrants whose name appear hereon, or their authorized replacement, hereby agree that the Ohio State USBC, its officers and agents shall be liable only to the extent of returning entry fees if and when these entrants shall be prevented from bowling any event in the tournament through delay, unexpected, yet necessary, schedule change, or premature termination of the tournament, which may be brought about by war, national emergency or emergencies or causes relating thereto or resulting therefrom, fires, terrorist threats, strikes, lockouts, pandemics, labor difficulties or other causes beyond the control of the Ohio State USBC

2024 OHIO STATE USBC YOUTH - PEPSI CHAMPIONSHIPS

STATE RULES AND FORMAT

1. This tournament is certified by the United States Bowling Congress (Certification #5016 and #5017) and shall be governed by USBC rules. Competition is based on scratch scores for all divisions of the Ohio State Youth – Pepsi Championships.
2. This tournament is a one-time entry. If an individual who qualified cannot participate in the State competition, additional State advancers will be eligible based on the order in which they finished in the District level competition.
3. Advancement ratio from the District level competition to the State level competition is one (1) out of every two (2) entries, or major fraction thereof, including last-place ties. In all cases, at least one (1) individual per division shall advance.
4. Advancers out of the district level must remain in the division they qualified in during all subsequent levels. Participation in more than one District will result in automatic disqualification.
5. State competition will take place for all divisions at **Columbus Square Bowling Palace, 5707 Forest Hills Blvd. Columbus, Ohio 43231** on May 3rd, 4th, 5th & May 10th, 11th, & 12th, 2024.
6. Participants & parents/guardians must be aware of each competition level in the State/District and all associated rules, fees, and deadlines.
7. **Deadline for ON-LINE REGISTRATION is April 17, 2024 at 11:59:59.** No refunds will be given once the confirmation has been issued. Additional state advancers must receive consideration in the order the bowler placed in their division.
8. Competition shall be conducted in ten (10) divisions total:

These divisions are based on the participant’s date of birth as of July 31, 2024. The **U8 and U10 divisions will bowl three (3) games** on the same pair of lanes at the State level; the **U12, U15, and U18 divisions will bowl six (6) games** on the same pair of lanes at the State level.

No refunds will be given once the confirmation has been issued.

Awards and Scholarship fees are returned 100% to the bowlers.

10. Dress code: Entrants are expected to wear suitable attire. Use good judgment when selecting the appropriate attire. Examples of ***prohibited attire*** include but are not limited to: **short shorts or any shorts, pants hanging showing underwear and/or body parts, headgear/headwear, T-**

shirts with alcohol or cigarette advertisements, sleeveless shirts/blouses or tank tops.

Bowlers will be required to change if attire is deemed inappropriate by the Tournament Director. The Tournament Director's decision will be final. Failure to comply with any dress code rule will result in a verbal warning and apparel change (if applicable). Second offense will result in disqualification from the tournament. Please be presentable. **Inappropriate language or gestures or gambling will not be permitted. Electronic devices (including cell phones) will not be permitted on the approach during delivery.**

11. Tobacco products, e-cigarettes, or alcohol will not be allowed by the athletes or guests on the concourse or in the settee area during competition.
12. Bowlers must show a current USBC membership card at check-in. If they do not have a current membership card, they can go to www.bowl.com under "Find a Member" and follow the prompts to print a card. (Effective July 1, 2016 you must have a current USBC membership number to create a user ID and password to access "Find a Member".)
13. No substitutes will be permitted. However, the next bowler in line from the same District may be used as a replacement for a bowler who has indicated that they would not be able to participate in the tournament.
14. Competitors shall be allowed ten (10) minutes of practice prior to their starting time on their assigned lanes only. There will be no bowling by tournament bowlers on the tournament lanes prior to the start of the tournament on their scheduled tournament day. A bowler may only receive (1) re-rack per game and must be approved by a tournament official.
15. Bowlers arriving late shall begin play with the frame then being bowled. Frames missed shall be credited with a zero. Frames may not be made up. Bowlers not present to bowl when it is their turn will be credited with a zero for that frame.
16. Claims for errors in scoring or general playing rules must be made to the Tournament Director no later the start of the next block or thirty (30) minutes after the completion of the competition. Questionable errors shall be decided upon by the Tournament Director. All other protests must be confirmed in writing to the State Tournament Director within seventy-two (72) hours. Under this rule, each protest must be specific.
17. Symbolic awards will be given to all bowlers in each of the divisions who participate in the state level finals.
18. Scholarships will be awarded at a ratio of one (1) out of every seven (7) entries per division or major fraction thereof, including last place ties, and based on the number of entries received at the state level in each division.
19. The highest qualifier – both girl and boy - in the 12 and under, 15 and under, and 18 and under divisions will receive one paid entry into the 2024 Junior Gold Championships, July 12-20, 2024 in Detroit, MI provided by USBC National Headquarters. If the 12 and under, 15 and under, 18 and under division champion is unable to attend and participate in the 2024 Junior Gold Championships the athlete will still retain the state scholarship, but the berth to the 2024 Junior Gold Championships will be awarded to the next eligible Junior Gold Member athlete. Winners are not confirmed as national finalists until they receive a confirmation letter from USBC.
ADVANCERS TO THE 2024 JUNIOR GOLD CHAMPIONSHIPS WILL BE REQUIRED TO BE ACCOMPANIED BY A PARENT, COACH OR GUARDIAN.
20. ***OPTIONAL JUNIOR GOLD QUALIFIER:*** Athletes must be a current Junior Gold member. The bowler must pay the event entry fee prior to bowling their assigned squad.
21. ***The Ohio State Pepsi Junior Gold qualifying*** event is open to 12 and under/15 and under/18 and under Boys/Girls only. (Younger bowlers, who have competed in these divisions with a completed waiver, may also participate.)
22. The advancement ratio from the Ohio State USBC Youth – Pepsi Championships Junior Gold qualifying event to the **2025 Junior Gold Championships** (location and date TBA) will be one (1) out of every seven (7) entries or major fraction thereof, in each of the three divisions: 12 and under, 15 and under, 18 and under. The cost per entry is \$30 for the U12 division, \$35 for the U15 division, and \$40 for the U18 division.

23. Advancers will receive a paid entry into the **2025 Junior Gold Championships**. In the event of a tie for the first place position advancing to the Junior Gold Championship, the highest game bowled will be used as the tiebreaker; if a tie still exists, then the second highest game bowled will be used. If a tie still exists, then the third highest game bowled will be used.
24. All participants & parents/guardians agree to allow the Ohio State USBC to use their photograph for publicity purposes. In the event the Ohio State USBC arranges for telecasts or broadcasts of the tournament, it would be without cost to participants/parents/guardians and participants/parents/guardians would not share any revenue derived therefrom.
25. USBC rules will govern all bowling during the tournament. The Tournament Director will be responsible for enforcing the rules and resolving disputes during the tournament. Only tournament officials and bowlers are permitted in the bowling area. The bowler, by voluntary participation in the Championships, agrees to comply with the final decision of the Tournament Director.
