# VERMONT STATE YOUTH 2023-2024 PEPSI TOURNAMENT 

State Level Rules and Format

1. This tournament is USBC certified \#4779 and shall be governed by USBC rules. Competition will take place Saturday, November 4, 2023 at:

2. Competition is open to all 2023-2024 youth bowlers with a USBC certified and a Vermont state membership. If a bowler is under suspension or has violated USBC Rule \#400, the bowler is not eligible to participate in this tournament.

Advancers out of the league level must remain in the division they qualified in during all subsequent levels. If a bowler advances out of the league level in more than one state/zone, the bowler must declare one state/zone to continue competing in before the next competition level. Participation in any level of competition past the league level in more than one state/zone will result in automatic disqualification.
3. This is a scratch-based tournament with scholarships in all divisions and awarding of Junior Gold qualification in U12, U15 and U18 divisions.
4. Entry deadline for this tournament is October 13, 2023. Entry forms, fees and any scholarship funds must be submitted to the tournament director by this date. Entries will not be accepted without payment.
5. Competition in this tournament will be conducted in the following divisions at the indicated times. The divisions are based on the participant's age as of August 1, 2023. Athletes must compete in their proper age division in all levels of competition. Athletes must be Junior Gold Members or be eligible and buy membership prior to advancement to the Junior Gold Championships.

7. Symbolic awards shall be available in the U10 Divisions on a ratio of at least 1 in 5 entries. No symbolic awards will be presented in the U12, U15 \& U18 Divisions. Scholarship awards shall be available in each division on a ratio of at least 1 in 10 entries. The dollar amount of scholarship awards shall be determined by the number of eligible bowlers in each division.

The first-place winners of the U12, U15 and U18 divisions for both Girls and Boys will advance to the 2024 Junior Gold Championships being held July $12^{\text {th }}-$ July $20^{\text {th }}$. They must be USBC Junior Gold members to advance to the Junior Gold Championships. Bowlers without a current Junior Gold membership must purchase a Junior Gold membership prior to June 5th. IBC Youth will waive the $\$ 200$ (U18), $\$ 150$ (U15), and $\$ 100$ (U12) entry fee for these athletes. These athletes will compete for additional scholarships available to all athletes at the Junior Gold Championships, as well as other prizes and awards. All U.S. citizens are vying for a spot on USBC Junior Team USA 2025 to represent the United States in national and international competition. If the U12, U15 or U18 Division Champion is unwilling to become a Junior Gold member, they will not advance to the Junior Gold Championships. However, the athlete will still retain the state/zone scholarship, but the berth to the Junior Gold Championships will be awarded to the next eligible athlete.

9. Conduct: All bowlers must conduct themselves appropriately. Each and every incident will be handled on an individual basis, up to and including removal from the tournament. The tournament director shall make the final determination.

10. Bowlers shall receive at minimum two (2) practice balls on each of their starting pair of lanes.
11. No substitutes will be permitted once athletes have started tournament play; however, replacements may be used for bowlers not present thirty (30) minutes prior to the squad time as stated in Rule \#5.
12. If no replacement has been made, a bowler arriving late shall begin play and scoring shall begin with the frame currently being bowled. Missed frames shall be credited with zero score. Frames shall not be made up. Bowlers not present when it is their turn will be credited with a zero for that frame.
13. Only tournament bowlers and officials shall be permitted in the settee area.
14. Bowlers who are tied in a position receiving a scholarship award shall receive equal scholarships.
15. Claims for errors in scoring or general playing rules must be made to the tournament director no later than the start of the next block or 30 minutes after the completion of competition. The tournament director shall rule on questionable errors. All other protests must be confirmed in writing to the tournament director within 72 hours of the infraction. Under this rule, each protest must be specific.
16. The Vermont State USBC Youth Pepsi Tournament Committee shall determine all matters not covered by these rules and regulations. The Vermont State USBC Youth Pepsi Tournament Committee reserves the right to accept or reject any participant.
17. Bowlers may pick up Sponsor Sign-Up Sheets from their league officials or request from tournament director. Bowlers are encouraged to collect additional scholarship money up to the entry deadline.
18. Brattleboro Bowl will be providing pizza and a small fountain drink to bowlers of this event. Each bowler will receive a coupon for the pizza and drink at time of check-in. If bowler and spectators are welcome to order at their expense from the house menu.
