## 2024 West Virginia State USBC Pepsi-Tournament Rules

1. WV State USBC Pepsi Championship is certified, all USBC rules and regulations will be in effect.
2. Bowler must be a USBC youth member, and bowl in a WV USBC certified youth league.
3. Competition: March 2 @ 2 PM, March $3 @ 9$ AM, March 9 @ 9 AM. Finals March 10.
4. Squads times will be added if needed.
5. Competition shall be conducted in the following male and female division. Ages will be determined as of $8 / 01 / 2023$. U8 will consist of bowlers whose birthdate is $8 / 1 / 2015$ or later. U10 will consist of bowlers whose birthdate is $8 / 1 / 2013$ thru $7 / 31 / 2015$. U12 will consist of bowlers whose birthdate is $8 / 1 / 2011$ thru $7 / 31 / 2013$. U15 will consist of bowlers whose birthdate is $8 / 1 / 2008$ thru $7 / 31 / 2011$. U18 will consist of bowlers whose birthdate is 8/1/2005 thru 7/31/2008.
6. Symbolic awards $1^{\text {st }}, 2^{\text {nd }}, 3^{\text {rd }}$ and $4^{\text {th }}$ in all divisions (U8, U10, U12, U15, and U18).
7. All bowlers must wear proper attire. Dress code: NO shorts above the kneecaps, NO wearing of clothing depicting foul language or gestures. NO hats allowed. NO smoking or drinking of alcohol in the center.
8. No entry fee will be returned after tournament closing date.
9. Tournament Format: Bowlers in U8, \& U10 will bowl a 3-game series without advancement.
10. Divisions U12, U15, \& U18 will bowl a 3-game series.

For Divisions U12, U15 \& U18, if we have a minimum of 8 entries in that division, $50 \%$ of the entries will go onto the finals, with a maximum of 24 moving onto the finals. If we have less than 8 entries in the division, 4 entries will move to the finals.
All pin fall from the previous games will be dropped each round. Bowlers will bowl 3 games, then the top 5 will move onto the step ladder finals to determine the champion.
The top qualifier in Divisions U12, U15 \& U18 will be awarded additional scholarship money in their SMART account.
11. Finals are on March 10, 2024. Finals times for each age group will be announced once the number of entries have been determined.
12. Scholarship fee returned $100 \%$ Scholarship will be awarded as follows: all divisions 1 out of 10 . Scholarship will be held in the USBC SMART FUND \#08552
13. Competitors will be allowed 10 minutes of practice. Bowlers and officials only allowed in the seating area. Coaching is permitted but BOWLER must come back to the coach or parent on the carpet area.
14. Bowler(s) arriving late shall begin play and score shall count beginning with that frame then being bowled. Missed frames shall be credited with a zero. Bowler(s) not present to bowl when it's their turn will be credited with a zero for that frame.
15. Only bowlers, score keepers and tournament officials will be allowed in the immediate bowling area.
16. Claims for errors in scoring or general playing rules must be given to the tournament director no later than the start of the block or 30 minutes after the completion of competition. Questionable errors shall be decided by the tournament director. All other protests must be submitted in writing to the tournament director before the awards are presented. Under this rule, each protest must be specific in itself.
17. If a bowler cannot finish their game(s), they will receive a score of zero for the remaining frame(s)/game(s).
18. The First-place winners of the U12, U15, and U18 divisions for both Males and Females will advance to the 2024 Junior Gold Championships on July 8-20, 2024, location will be Detroit. They must be USBC Junior Gold members to advance to the Junior Gold Championships.
19. Bowlers without a current Junior Gold membership MUST purchase a Junior Gold membership prior to June 1st. USBC will waive the $\$ 200 \mathrm{U} 18$ and U15 and $\$ 100 \mathrm{U} 12$ entry fee. These athletes will compete for additional scholarships available to all athletes at the championships, and international competition.
20. If the U12, U15 and U18 Division Champion is unwilling or unable to become a Junior Gold member they will not advance to the Junior Gold Championships. However, the athlete will still retain the State/zone scholarship, but the spot to the Junior Gold Championships will be awarded to the next eligible athlete. Travel expense for $1^{\text {st }}$ place winners will come from the ball raffles, and fund raisers. Eligible advancers must agree to bowl in the Junior Gold Championships, or failing to do so, agree to waive all rights. Replacements will be selected based on the order of finish in their division at the state/zone level. Replacements will occur all costs associated with changing airline ticket, if applicable.
21. Tournament Director is responsible for verification of memberships.
22. The tournament director has the right to disqualify a bowler if he or she violates USBC RULE 17d.
23. All Bowlers in the Host Zone MUST bowl the FIRST squad!
24. The WV State USBC board of directors will decide any questions not covered by these tournament rules.
